WEEKLY PAYROLL RECORDS REPORT & STATEMENT OF COMPLIANCE

In accordance with Massachusetts General Law c149, §27B, a true and accurate record must be kept of all persons employed on the public works project for which the enclosed rates have been provided. A Payroll Form has been printed on the preceding page(s) and includes all information required to be kept by law. Every Contractor and Subcontractor is required to keep these records and preserve them for a period of three years from the date of completion of the contract.

In addition, every contractor and subcontractor is required to submit a copy of their weekly payroll records to the awarding authority. This is required to be done on a weekly basis. Once collected, the awarding authority is also required to preserve those records for three years.

In addition, each contractor, subcontractor or public body shall furnish to the Department of Labor & Workforce Development/Division of the Occupational Safety within fifteen days after the completion of its portion of the work a statement, executed by the contractor, subcontractor or public body who supervises the payment of wages in the following form:
